Special Events - Golf outing, legislative days, open houses, parades, and ribbon cuttings, Lake Festival and Santa House, Taste of Celina, and many more. We welcome all members to participate in these fun community events.

Seminars & Workshops - Periodically offered on a variety of pertinent subjects for the membership and the public. Often work with the Business Enterprise Center to bring you the best training possible.

Gift Certificate Program - Certificates are available in \$5, \$10, and \$20 denominations and sold to businesses or citizens through the Chamber office. Certificates can be redeemed at any participating Chamber Member. Businesses then bring the redeemed certificates to the Chamber to receive payment at face value upon presentation at the Chamber office. Only participating chamber members can accept gift certificates and bring them in for reimbursement. Reimbursement is made on site...no waiting for payment! This is a wonderful program that encourages local shopping and is NO COST to you.

Grand Lake Area Safety Council – A Chamber and Ohio BWC sponsored industry organization in the two county area that deals with Health, Safety and Environmental Issues. This council is designed to help our industries stay knowledgeable about government mandates, regulations, and compliances. Rebate eligible safety council members can also receive a discount on their BWC premiums.

Assesses Community Needs - Our office keeps a watchful eye on the needs of the Mercer County Community and acts where situation calls for activity from the chamber.
